

Steel Screw-Mount Grille for 8" Speaker: JG-8X

Square steel grille with beveled edges and white finish includes a separate subplate that direct-mounts an 8" speaker and enclosure. The direct-mount method allows a high quality 8" speaker with substantial motor structure weight to be supported by the enclosure instead of the grille.

FEATURES:

• **Construction:** Grille is a 20-gauge steel beveled frame with a radius corner cutout, welded 22-gauge perforated screen center, and white powder epoxy finish. The separate subplate is 21-gauge steel with black powder epoxy finish.

• Overall Dimensions: 12.375" square

• Mounting Projection: 0.375"


• Mounting Bolt Circle (subplate): 12.8" and 11.25" diameter

• Speaker Bolt Circle: 7.68" diameter

• Country of Origin: Made in USA with certified US steel


• Hardware (included):

- (4) 8-32 x 3/4" black oxide screws with nuts to mount an 8" EIA speaker to the subplate.



-(4) 8-32 x 3/4" white screws to mount the non-loadbearing grille to the enclosure.

A&E Specifications: The grille for 8" speakers shall be Lowell model JG-8X. It shall be
a 20-gauge steel beveled frame with a radius corner cutout, welded 22-gauge perforated
screen center and white powder epoxy finish. It shall include a separate subplate, which
shall be 21-gauge steel with black powder epoxy finish. Overall grille measurements shall
be 12.375" square with a mounting projection of 0.375". The subplate shall direct-mount
an 8" EIA speaker and enclosure. The non-loadbearing grille shall include white screws to
mount to the backbox. The grille and subplate shall be made in the U.S.A.


Rear (with subplate)

Note: Robust coaxial speakers, such as Lowell 8A50 or 8P100, require a large volume enclosure (greater than 4"D).
